All of our tours operate rain or shine [and we have rain ponchos available to rent for 1GBP]. Please arrive 5-10 minutes before the advertised start time for your tour. If you are late the tour may leave without you and there will be no right of refund, though we will try to re-schedule you into a later tour in exceptional circumstances. [Participants must be over 14yrs of age and over 5ft (1.5m) tall.]

CANCELLATION POLICY

Scotland Bike Tours offers 100% refunds if the reservation is cancelled or amended by the customer more than 72 hours (3 days) prior to the scheduled tour. Scotland Bike Tours does not offer refunds for any reason within 72 hours of the scheduled tour. Scotland Bike Tours reserves the right to cancel a tour or to vary the time of departure without notice in the light of circumstances beyond its control.
